

Business Rates Retail Relief (2014/15 and 2015/16)

Business rates relief of **up to £1,000** is available to all businesses who occupy retail properties with a rateable value of £50,000 or less, that are wholly or mainly being used as shops, restaurants, cafes and drinking establishments in 2014/15 and this has increased to **up to £1,500** in 2015/16, up to state aid limits.

The retail properties that will benefit from the relief are detailed overleaf and you are invited to apply.

The award of this relief must comply with EU law on State Aid. The application form requires you to confirm that you have not received any other State Aid that exceeds in total €200,000 (euros) (including any other Retail Relief you are being granted for other premises) under the De Minimis Regulations.

Properties which will benefit from relief

Relief will apply to occupied properties (not empty) with a rateable value of £50,000 or less that are used for the sale of goods to the public, the provision of certain services to the public or used for the sale of food and / or drink to the public. The relief will be applied after any other reliefs.

You will need to confirm that your premises falls into one of the categories listed below in your application. Shops (such as: florist, bakers, butchers, grocers, greengrocers, jewellers, stationers, off licence, chemists, newsagents, hardware stores, supermarkets etc).
