4. Contract of Registration

This section sets out the terms and conditions which govern the use by any participant (the "User") of the Carnegie Club ("the Club"), and by which you agree to be bound as the User's parent or carer. If you do not agree that these terms and conditions bind both you and the User, then Leeds Metropolitan University ("us", "we" or "Leeds Met") will not agree to the User taking part in the Club.

In consideration of the participation by the User of the Club, you agree that you and the User shall be bound by these terms and conditions:

1. You have applied for a place at the Club in respect of and on behalf of the User indicated on this form. You make this application with the intention that both you and the User shall be bound by the terms of this agreement. To the extent that this agreement should ever be found not to be binding on the User, you agree that this shall have no effect on your obligations under this agreement.
2. Upon receipt of a correctly completed application made by you, Leeds Met will notify you if the application has been accepted. Upon acceptance of your application the terms and conditions of this agreement will become binding on you, the User, and Leeds Met.
3. You agree and understand that Leeds Met will not make a financial profit from providing the services of the Club. You therefore agree that it is reasonable and appropriate that, subject to paragraph 4 below, Leeds Met shall only be liable for any personal injury or death to the extent that such is caused by the negligence of Leeds Met or its staff or representatives, and that Leeds Met shall not have any liability in any other circumstances. Subject to the foregoing, Leeds Met shall have no liability for any loss of profit, indirect, special or consequential loss or damage.
4. Nothing in this agreement is intended to or shall have the effect of limiting or excluding Leeds Met's liability beyond that which is permitted by law.
5. You agree that neither Leeds Met nor any of its staff or representatives shall be liable or responsible for any losses of or damage to property belonging to you or to the User. You understand that it is advisable to ensure that such property is the subject of appropriate insurance and personal care.
6. You agree and acknowledge that Leeds Met shall have no liability for any action or omission of the User which causes harm or loss to any other participants in the Club, staff members or third party or to any property. As such you agree to hold Leeds Met harmless and to indemnify it against any liability or loss which Leeds Met incurs or suffers as a result of any such action or omission of the User.
7. You give permission for the User to take part in any activity or trip organised as part of the Club. In the event of an emergency, you give permission for Leeds Met to take such measures as are reasonably necessary to protect health of the User including to admit the User to hospital, and/or procure the administration of any medical procedures

reasonably necessary, including, without limitation x-rays, blood transfusions, injections, anaesthesia or surgery.

8. You agree, and agree on behalf of the User, to abide by the rules and regulations of the Club and Leeds Met from time to time. Conduct that, in the opinion of Leeds Met, is not in the best interests of Leeds Met or the Club may result in the discharge of the User from the Club without benefit or refund. No allowance or refund will be made in the event of late arrival or early departure.
9. You understand and agree that data derived from the Club may be used by Leeds Met for the purpose of audit and evaluation. Any such audit and evaluation will use the data for statistical purposes only, and will not identify the individuals by name.
10. In signing this agreement you agree to Leeds Met processing personal data contained in the enrolment form about you and the User and other data which Leeds Met may obtain, for any purpose connected with this agreement, or for any other legitimate reason. Leeds Met will handle all such information in accordance with all applicable Data Protection legislation and with due regard to confidentiality.
11. This agreement constitutes the entire understanding and contract between Leeds Met and you and the User and supersedes all and any previous representations or agreements. Each of the parties acknowledges and agrees that in entering into this agreement it does not rely on, and shall have no remedy in respect of, any statement, representation, warranty or understanding (whether negligently or innocently made) other than as expressly set out in this agreement.
12. This Agreement and any matter arising from or in connection with it shall be governed by and construed in accordance with the law of England and Wales, and shall be subject to the exclusive jurisdiction of the courts of England and Wales.
