TERMS OF REFERENCE (v. 1.0)

- AIM: To co-ordinate and drive plans forward focused on the Sowerby Bridge Copley Valley Development Scheme ("the Development Scheme").
- SCOPE: The area included in the Development Scheme is to the south-west of Wakefield Road, and is bounded (approximately) by Fall Lane/Holmes Road to the east and Hollas Lane to the west.
- OBJECTIVES:
 - To oversee the successful delivery of the Development Scheme;
 - To maximise the investment opportunities provided by the Development Scheme;
 - To positively involve, communicate and engage local stakeholders, community groups and local people with the Development Scheme.
 - **METHODS OF WORKING:** The Board is expected to meet every 2 months with a scheduled timetable agreed for each year.

At each meeting the board will receive a report on progress against key project milestones and other priority targets as set by the board. The board will receive written monthly update reports between meetings.

The board may establish Working Groups with delegated responsibility for individual projects or activities. Board meetings are not open to the public but minutes will be published on the Council's website. There may be some items that will be exempt, for example those which are commercially sensitive.
