**20 APPLICATION FOR THE REVIEW OF PREMISES LICENCE: 22 BAR AND SMOKEHOUSE, 10-12 VICTORIA PLACE, NORTHOWRAM, HALIFAX HX3 7HY**

The Assistant Director, Neighbourhoods submitted a written report seeking consideration of an application for the Review of a Premises Licence under Section 51 of the Licensing Act 2003 and any relevant representations.

The Sub Committee considered the report presented and representations made at the hearing, and having considered the serious concerns of the Responsible Authority, West Yorkshire Police relating to:

- the prevention of crime and disorder;
- the protection of children from harm;
- public safety; and
- the prevention of public nuisance,

and had due regard to the provisions of the Licensing Act 2003, the statutory guidance issued under section 182 of the Act, the Council's Statement of Licensing Policy and the relevant provisions of the Human Rights Act.

**RESOLVED** that the conditions in the Premises Licence VEPREM1142 for 22 Bar and Smokehouse, 10-12 Victoria Place, Northowram, Halifax HX3 7HY be modified for the following reasons:-

- The applicant had shown that they had attempted to resolve most issues raised however, they had been unable to demonstrate being able to address early morning noise issues when their customers were vacating the premises.
- The Licensing Sub Committee had no confidence that the nuisance would be resolved by maintaining the existing operating hours.

The conditions in the Premises Licence be modified as follows:

- Performance of live music (Indoors):

Monday to Sunday 10:30am to 10:30pm.

Removal of outdoors Monday to Sunday.

- Playing of recorded music (indoors):

Monday to Saturday 10:00am to 12:00am.

Sunday 10:00am to 11pm.

- Late night refreshments (indoors and outdoors):

Monday to Saturday 11:00pm to 12:00am.

Removal of Sunday.

Monday to Saturday 9:00am to 12:00am following morning.

Sunday 9:00am to 11:00pm.

- The opening hours of the premises to be as per alcohol consumption:

Monday to Saturday 9:00am to 12:00am following morning.

Sunday 9:00am to 11:00pm.
