The purpose of this report is to provide a draft of the revised Calderdale Wellbeing Strategy and seek agreement to a set of next steps.

3. Summary of Progress

The Health & Well-being Board (HWB) agreed in October 2018 at an informal meeting refresh of its Wellbeing Strategy and identified leadership from the Local Authority and the CCG to take the work forward. The Board also agreed the approach taken to development of indicators to support delivery of the Strategy. The Wellbeing Strategy was seen, alongside the Inclusive Economy Strategy, as the two key strategic pillars for delivering our place-based ambition.

The Health & Wellbeing Delivery Group, representing the HWB partnership, was asked to have oversight of the Strategy's development and ultimately its delivery. It was agreed that initial small-scale engagement on the content of the Strategy should take place in advance its presentation to HWB formally on 20 June, and the engagement process is described below.

5. Engagement Feedback

The engagement feedback was focused mainly on:

- Ensuring alignment with delivery of Vision 2024 and the Inclusive Economy Strategy.
- Recognition that the Strategy is consistent with the aspiration set out in Calderdale Cares for integrated health and care.
- Keeping the Strategy a high level one, with a commitment to developing Annual Improvement Plans to describe priorities.
- Keeping the focus on hearts and minds, rather than a lengthy document.
- Using a small number of key indicators – developing new indicators which respond to our priorities
- Developing targets for each indicator and improvement trajectories which can be measured and reported for HWB assurance.
- Including the emergence of Primary Care Networks as a key delivery vehicle, with a set of principles which bind the work of localities to delivery of our agreed place-based vision.

6. Next Steps

The draft Strategy is being shared with the Board for their comments, and the following next steps are suggested for their consideration;

- A final draft is developed, taking into account changes agreed at the HWB informal session on 12 June and the formal meeting on 20 June. This final version will be presented to the HWB for adoption at the August 2019 meeting.
- Further engagement on delivery of the Strategy takes place as part of the Engagement Strategy being developed for Calderdale Cares.

- Communication on the Strategy takes place as part of the Communications Strategy being developed for Calderdale Cares.
- A first version of the Annual Improvement Plan, targets and trajectories are prepared for the next informal HWB session, and signed off at the next formal HWB Board.
- There is a standing item at HWB which highlight reports progress and exceptions.
