Representatives from North East & Yorkshire Region Specialised Commissioning Team, NHS England, will present the proposals that will include an outline of the current service provision; the proposed changes; key drivers for change including details of the national specification and standards for specialised vascular care; and expected patient flows.

The Committee will also have an opportunity to consider the impact of the proposals on other clinical services to include identifying the key clinical interdependencies with other services and the effect on the continuing provision of these services. (Cornelle Parker, Deputy Medical Director, CHFT, Karen Stone, Medical Director, Mid-Yorks Trust and John Stoves, Consultant in Nephrology and General Medicine and Renal Clinical Lead will attend to contribute to these discussions)

The Committee may also wish to examine workforce challenges and to assess the sustainability of the workforce to including: staffing levels in interventional radiology, vascular surgeons and other key interdependent services; and considering the work that is being done regionally to resource these positions. (Health Education England have been invited to attend to contribute to these discussions).

The Committee will next meet on 24<sup>th</sup> February 2020 at 10:30 hours in Council Chamber Huddersfield Town Hall to receive a Consultation Feedback Report from NHS England and to receive the details of the outcomes from the consultation and details of NHSE's recommended option for the delivery of specialised vascular services across West Yorkshire.
