7. Improving Population Health Programme Health Inequalities Update (Programme lead for improving population health, West Yorkshire and Harrogate Health and Care Partnership, <u>written report</u>)

Reducing Health inequalities is a priority for the West Yorkshire and Harrogate Health and care Partnership. This item is an opportunity to discuss the recent independent review into the impact of COVID-19 on health inequalities and support needed for Black Asian and Minority Ethnic (BAME) communities and staff. It will also present an opportunity to discuss other aspects of health inequalities.

Joint Committee Members are asked to be prepared to update the Joint Committee on activity within their own local authority to address health inequalities.
