OBJECTIVES

- To give the Scrutiny Board information about the implications of the Health and Care Bill
- To understand how the Constitution underpinning the ICS is being drawn up, its key features, and when it will be available for scrutiny
- To understand the implication of “primacy of Calderdale” and how this will work in practice.
- To allow the Scrutiny Board to assure itself that the proposals for implementing the Bill will result in tangible improvements in the health and wellbeing of Calderdale people and will address health inequalities
- To understand how the Health and Care Bill addresses workforce planning
- To assure the Scrutiny Board that local accountability is enhanced by the way in which the Health and Care Bill is implemented and that the principle of subsidiarity runs throughout the implementation of the Bill.
- To allow the Scrutiny Board to assure itself that the governance structures that will be introduced will be transparent, have published proceedings that are open to the public to observe and that decision making is undertaken at a “place” level as much as possible.
- To understand any changes that will need to occur at in the way that scrutiny takes place, in Calderdale and at West Yorkshire level, to ensure that questions can be asked directly of key decision takers
- To consider the implications of the Bill for social care services
- To consider the implications of the Bill for public health, including the public health duties of Calderdale Council, and including fluoridation of the water supply.
- To consider the implications of the Bill for the commissioning of specialist services including dental services
- To identify recommendations to make to Cabinet, Calderdale CCG and West Yorkshire Health and Care Partnership about the implementation of the Bill
