The Borough Council of Calderdale in exercise of its powers under Section 84(1) of the Road Traffic Regulation Act 1984, ("the Act ") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of roads situate in Mixenden, Halifax, West Yorkshire and specified in the Schedule to this Order and shown for the purposes of identification on the plan attached to this Order.
2. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
3. Item 27 of the first schedule of The Borough Council of Calderdale (Speed Limit) (Mixenden) (No.4) Order 2013 is hereby revoked.
4. This Order shall come into operation on the 7<sup>th</sup> October 2016 and may be cited as "The Borough Council of Calderdale (Speed Limit) (Mixenden) (No. 04) Order 2013 (Variation No. 01) Order 2016".

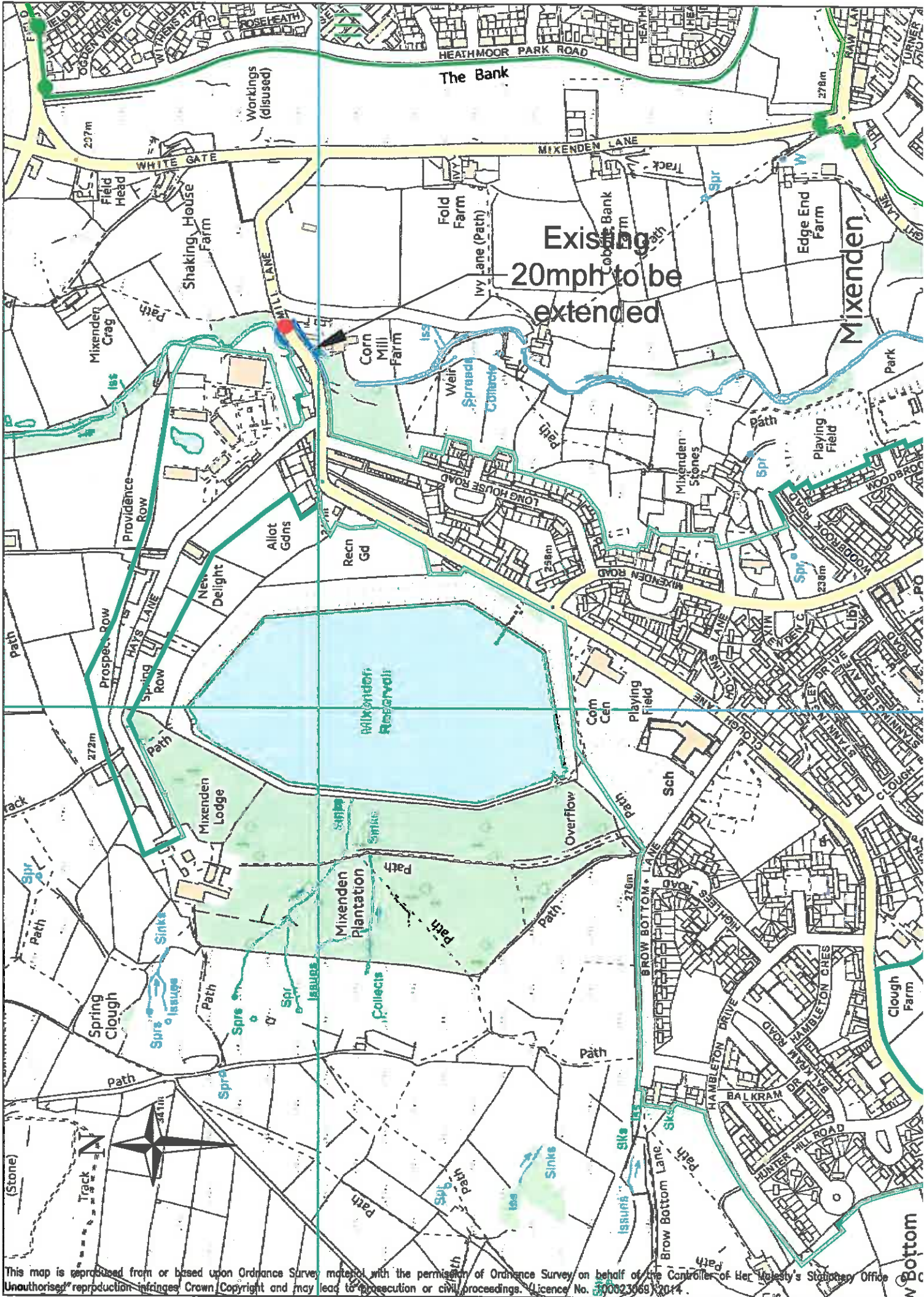
