



THE BOROUGH COUNCIL OF CALDERDALE
(SPEED LIMIT) (NORTHOWRAM) ORDER 2016

NOTICE is hereby given in accordance with Regulation 14 of The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 that the Borough Council of Calderdale intend to make an order in exercise of its powers under the Road Traffic Regulation Act 1984.

The order will introduce a 20mph speed limit on the full length (unless specified) of the following roads within Northowram:

Almond Court; Anderton Fold; Aspen Grove; Baxter Lane; Blackthorn Close; Chelsea Mansions; Coley View; Daleson Close; Drake Court; Greencroft Avenue; Greenfield Close; Hall Close; Hall Lane (from its junction with Northowram Green for a distance of approx. 190m); Haven Close; Hedge Top Lane; Heywood Close; Heywood Court; Hill View Gardens; Hornbeam Grove; Hough; Joseph Avenue; Juniper Court; Longfield Avenue; Lydgate; Marldon Road; Mulberry Way; Nettle Grove; Newlands Avenue; Newlands Drive; Newlands Grove; Northowram Green (from its junction with Lydgate for a distance of approx. 385m); Oaklands Avenue; Park View Avenue; Queen Victoria Crescent; Rowan Way; Sinderhill Court; Spruce Drive; St Matthews Drive; Stephen Close; Stephen Row; Tetley Lane; Towngate; Upper Hall View; Upper Lane (from its junction with Towngate for a distance of approx. 600m); Victoria Drive; Westercroft Lane (from its junction with Bradford Road for a distance of approx. 250m); Westercroft View; Windmill Crescent; Windmill Drive; Windmill Hill; Wytehill Chase; Yarborough Croft; Yew Trees Avenue.
